FC0105/24 MINUTES OF THE PREVIOUS MEETING

FC0106/24 PUBLIC PARTICIPATION

- A resident attended to raise awareness of the re-launch of Safe Leys.
- Oxford City Council Communities & Neighbourhoods provided an update on health inequality projects and introduced the 'Leys Engine' community information website initiative.

FC0107/24 REGENERATION UPDATE

An update was received outlining these key points

- Block A resubmission planned for mid-April 2025, incorporating new fire safety standard BS9991.
- Block D and Block C progressing with concrete pour on 8th floor starting next week.
- Frame completion expected by end of February.
- Knights Road development progressing with first-fix installations.
- Public right of way from Knights Road to Kassam to close from 10th February, with temporary footpath diversion via Orion Academy.
- Blackbird Leys Road by shops to close signage in place.

- Planning application submitted for temporary marketing suite/information centre near Holy Family Church.
- Outline application for community centre and public realm under review.
- Clarification provided that the community centre would be completed before Block A occupation.
- Residents raised concerns about construction vehicle speeds on Knights Road, particularly near Orion Academy. Additional safety measures and signage for school children were discussed.
